A shareholder must satisfy a 61-day holding period with respect to any distributions of qualifying dividends in order to obtain the benefit of the lower tax rate. Corporate Dividends Received Deduction

The amount eligible for the corporate dividends received deduction as a percentage of total ordinary income is: Hickory – 26.81%; Balanced – 30.84%; Core Plus Income – 0.00%; Short Duration Income – 0.00%. Tax-Exempt Interest Dividends

Of the tax-exempt interest dividends reported to you on your Form 1099-DIV, Box 11, 100% is tax-exempt for federal income tax purposes. A portion of these tax-exempt interest dividends may also be exempt from state or local tax, depending on the state and local tax laws that apply where you file your return. For Nebraska residents, 90.09% of the amount reported in Box 11 is exempt from Nebraska income tax. Please consult your tax adviser for more information.

Alternative Minimum Tax

A portion of the tax-exempt interest dividends is from private activity bonds issued after August 7, 1986, and is a tax preference item subject to the Federal Alternative Minimum Tax. Your share of the tax-exempt interest dividends for such bonds is 4.03% of the amount reported on Form 1099-DIV, Box 11. This amount is reported to you on your Form 1099-DIV, Box 12.

Assets by State

State and local governments may require residents to pay intangible or personal property tax on investments. The table above provides the percentage of assets that the Nebraska Tax-Free Income Fund had invested in each state at the end of 2018. Please consult your tax adviser for more information.

Ordinary Income Dividends

A portion of the total dividends paid by the Nebraska Tax-Free Income Fund is considered taxable for federal and state income tax purposes. This amount is reported to you on your Form 1099-DIV, Box 1a, if applicable.
